

3B. Project Description

1. Provide a description that addresses the entire scope of the proposed project.

The project will provide permanent housing for four (4) chronically homeless, unaccompanied adults with severe mental illness. The tenant based rental assistance will secure four (4) 1-bedroom units in sites scattered throughout the City of Chico, and expanded service areas of Gridley, Oroville, and Paradise as approved by HUD on December 5, 2016. The Butte County Department of Behavioral Health (BCDBH) staff will perform outreach to persons who are chronically homeless and experiencing symptoms of mental illness and substance use disorder. BCDBH staff also responds to referrals from law enforcement, code enforcement, emergency homeless shelters, and Psychiatric Health Facilities that identify potential program participants. BCDBH intends to participate in the CoC Coordinated Entry system.

BCDBH uses a housing first model. Our project policies do not screen out homeless persons on basis of rental, credit, or criminal histories. Further, we do not require service participation, sobriety or medication compliance. We do try to house participants as quickly as possible and after housed, engage them in services. Individuals who meet the eligibility criteria and are living in the streets may have access to temporary emergency shelter (motel designated as emergency shelter by BCDBH), while the participant completes the application process and identifies a rental unit with the case manager. Having the participant help to identify a unit creates a vested interest and contributes to an individual's desire to remain in permanent housing. BCDBH contracts with our local Public Housing Authority to assist with determining rental assistance, conduct housing quality inspections, and send, via electronic process, monthly landlord payments.

BCDBH utilizes a recovery model approach to determine the day-to-day support services based on a clinical and functional assessment of the individual's needs. A case manager will collaborate with the participant to complete an action oriented supportive service plan. The plan is designed to assist the participant retain housing and develop a greater degree of self-sufficiency. The case manager and/or peer recovery specialist may provide the following volunteer based services and/or assist with referrals to community-based services:

- Identify, secure, and maintain permanent housing
- Obtain services: medical, dental, optical, mental health, employment and vocational training
- Access community support services: education, transportation, libraries, assistance with utility deposits, recovery support groups such as AA and NA
- Advocacy regarding health benefits, disability and/or legal issues
- Manage funds and/or develop budget skills
- Access mainstream benefits
- Apply for Housing Choice Voucher Program (Section 8) and other affordable housing apartment complexes (subject to open wait list)

3C. Dedicated Plus

Dedicated and DedicatedPLUS

A “100% Dedicated” project is a permanent supportive housing project that commits 100% of its beds to chronically homeless individuals and families, according to NOFA Section III.3.b.

A “DedicatedPLUS” project is a permanent supportive housing project where 100% of the beds are dedicated to serve individuals with disabilities and families in which one adult or child has a disability, including unaccompanied homeless youth, that at a minimum, meet ONE of the following criteria according to NOFA Section III.3.d:

- (2) residing in a transitional housing project that will be eliminated and meets the definition of chronically homeless in effect at the time in which the individual or family entered the transitional housing project;
- (3) residing in a place not meant for human habitation, emergency shelter, or safe haven; but the individuals or families experiencing chronic homelessness as defined at 24 CFR 578.3 had been admitted and enrolled in a permanent housing project within the last year and were unable to maintain a housing placement;
- (4) residing in transitional housing funded by a joint TH and PH-RRH component project and who were experiencing chronic homelessness as defined at 24 CFR 578.3 prior to entering the project;
- (5) residing and has resided in a place not meant for human habitation, a safe haven, or emergency shelter for at least 12 months in the last three years, but has not done so on four separate occasions; or
- (6) receiving assistance through a Department of Veterans Affairs(VA)-funded homeless assistance program and met one of the above criteria at initial intake to the VA's homeless assistance system.

A renewal project where 100 percent of the beds are dedicated in their current grant as described in NOFA Section III.A.3.b. must either become DedicatedPLUS or remain 100% Dedicated.
