Qhia Txog: Qhov CoC Hom Phiaj (24 CFR pat 578) yog ua los pab zej zos kom txhob muaj kev nyob qab choj; kom tau nyiaj los ntawm cov koom haum thiab lam thab npas es thiaj dhiav laib tsev rau cov neeg nyob qab choj; cov dim ntawv kev sib ntaus; cov neeg lhuas uas tsis muaj tsev nyob; kom mus cuag tau kev pab; thiab kom cov txawj hauj lwm mus nhriav tau hauj lwm ua.

2017 NOFA: Qhov HUD Continuum of Care Notice of Funding Availability (NOFA) rau qhov nyiaj xyoo 2017 tau muab tso tawm rau lub July 14, 2017. Nws qhia txog tias nyob rau xyoo 2017/18 muaj yuav txog li \$2 billion nyiaj lam thab npas saib xyuas los ntawm HUD thiab HEARTH Act los mus pab cov neej nyob qab choj.

Tag nrho cov nyiaj rau Butte County, nws hu ua Pro Rata Need, yog muaj li \$605,781. Qhov nyiaj xyoo, hu ua Annual Renewal Demand, yog muaj npaum li tsaib no qhov NOFA, \$528,301. Xyoo no NOFA ntxiv rau Permanent Housing Bonus yog \$34,210. Cov hom phiaj uas tau cov nyiaj no yuav tsum muab tag nrho 100% ntawm lawv cov txaj pw los mus rau cov neeg nyob qab choj, rau cov neeg qab choj nrhiav tsev nyob; DedicatedPlus cov hom phiaj uas muab tagnrog 100% ntawm lawv cov txaj pw rau cov xiam oob khab thiab rau cov neeg los yog cov tsev neeg uas yuav poob mus nyob qab choj (mus saib qhov NOFA qhia ntxiv txog cov tsev no). Tsis tas li, muaj li \$17,105 los mus pab rau cov Planning Grant, ntawv thov los ntawm Collaborative Applicant thiab siv rau CoC-wide planning.

Cov hom phiaj xav thov rau qhov CoC nyiaj no yuav tsum muaj:

1. Permanent Supportive Housing (PSH) yuav tsum muab tag nrho 100% los mus pab cov neeg tsis muaj tsev nyob;
2. Rapid Rehousing Projects (RRH), los ntxiv rau cov hluas tsis muaj niam muaj txiv;
3. Joint Transitional Housing thiab Permanent Housing-Rapid Rehousing Projects (Joint TH thiab PH-RRH), yog ib qho hom phiaj tshiab;
4. Dedicated Homeless Management Information Systems (HMIS) Projects; thiab
5. Cov hom phiaj uas pab txhawb txoj kev pab cov neeg qab choj no mus.

Cov hom phiaj uas tau tauj ntxiv mus no tej zaum yuav ntxiv tsev nyob, txaj pw, tig neeg ntxiv, los yog kev pab los ntawm cov nyiaj faib los yog ntawm qhov permanent housing bonus nyiaj xyoo no. Transitional, Supportive Services Only, thiab Safe Haven cov hom phiaj no tsuas yog muaj los ntawv qhov kev lhoov dua tshiab xwb.

Raws li xav tau, cov nyiaj pab no yuav muab faib raws li tsaib no; tiam sis HUD xav kom muab ntau ntau lub hom phiaj no los mus tso kom muaj Qib 1 thiab Qib 2 es thiaj paub tias lub hom phiaj twg tau ntau ntau npaum lica tsam ces tsis muaj nyiaj txaus. Tag nrho cov nyiaj rau Qib 1 yuav muaj li 94% los ntawm qhov Annual Renewal Demand. Qhov nyiaj rau Qib 2 tsuas tau li 6% los ntawm qhov Annual Renewal Demand thiab qhov Permanent Housing Bonus (yog ua tas daim ntawv thov nyiaj rau qhov Permanent Housing Bonus). HUD qhov kev saib saib xyuas qhov Qib 2 no yuav tsum muaj: 1) qhov CoC Consolidated Application Score; 2) qhov hom phiaj no poob rau qib dabtsi nyob rau hauv CoC qhov Priority Listing; thiab 3) yuav tsum ntxiv qhov kev pab Housing First. Cov CoC yuav tsum muaj qhov HMIS hom phiaj, li no es daim ntawv thov nyiaj rau HMIS Project thiaj li muaj nqi zog. Tsis tas li ntawv, NOFA xav kom muab cov CoC nyiaj no faib kom zoo nkauj es thiaj li mus raws li txoj cai NOFA Policy Priorities.

NOFA toob kas cov CoC saib xyuas cov ntawv thov nyiaj nyob ntawm ib cheeb tsam seb qhov twg toob kas kev pab tsaj thiab seb qhov twg yuav mus raws qhov 2017 NOFA Priorities hauv qab. Tamsim no daim ntawv thov nyiaj tseem ua tsis tau tiav ua ntej nws mus rau CoC cov Council.
